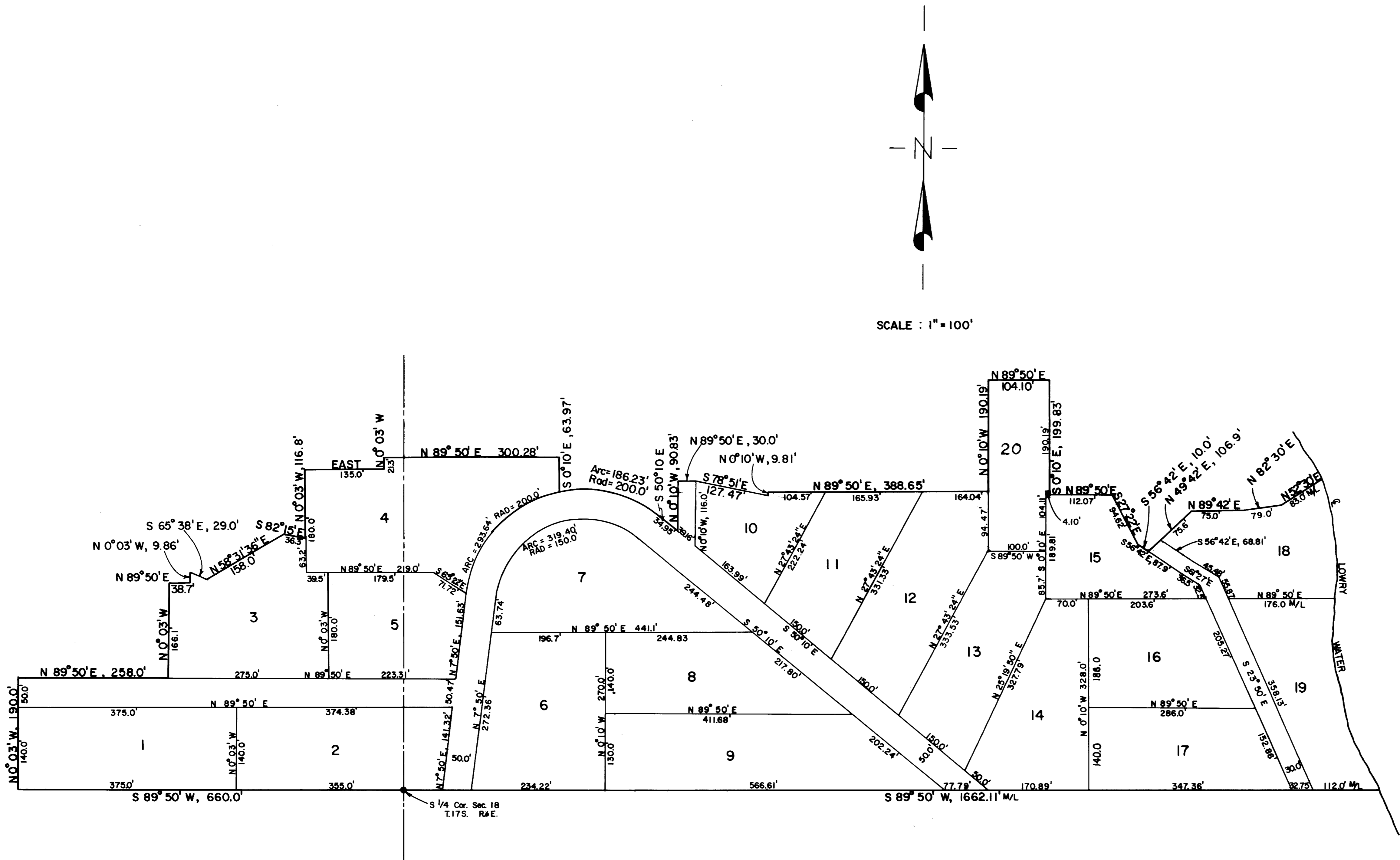

 UTAH STATE DIVISION OF HEALTH REGULATIONS.

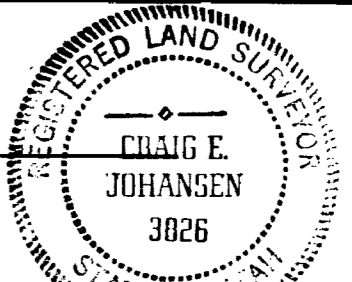
**SURVEYOR'S CERTIFICATE**
