DEDICATION

Know All Men By These Presents That we Carl Wilberg and Matilda Wilberg husband and wife of Castle-Dale, Utah, hereby certify and declare that we are the sole owners of the streets embraced in this plat; that the scale to which this plat is drawn is 200 ft. to 1 inch; that all lots shown thereon are 13 rods square; that all streets shown hereon are 6 rods wide except First, Maple, and Birch Streets which are 3 rods wide, that the following named streets and parts of streets as shown hereon viz, - First Street; Second Street from Maple Street to Oak Street and from Walnut Street to Birch Street; Third Street; Maple Street; Spruce Street from First Street to Third Street; Pine Street from Second Street to the S. E. Corner of Lot 2 Block 6 and N.E. Corner of Lot 3 Block 7; Oak Street from the East side of Second Street to Third Street allowing an opening 33 feet in width connecting Oak Street as shown; Walnut Street from First Street to Third Street and Birch Street; that this plat is hereby denominated Wilberg Subdivision of Castle-Dale Townsite Survey and the said streets are hereby dedicated to the use of the public.

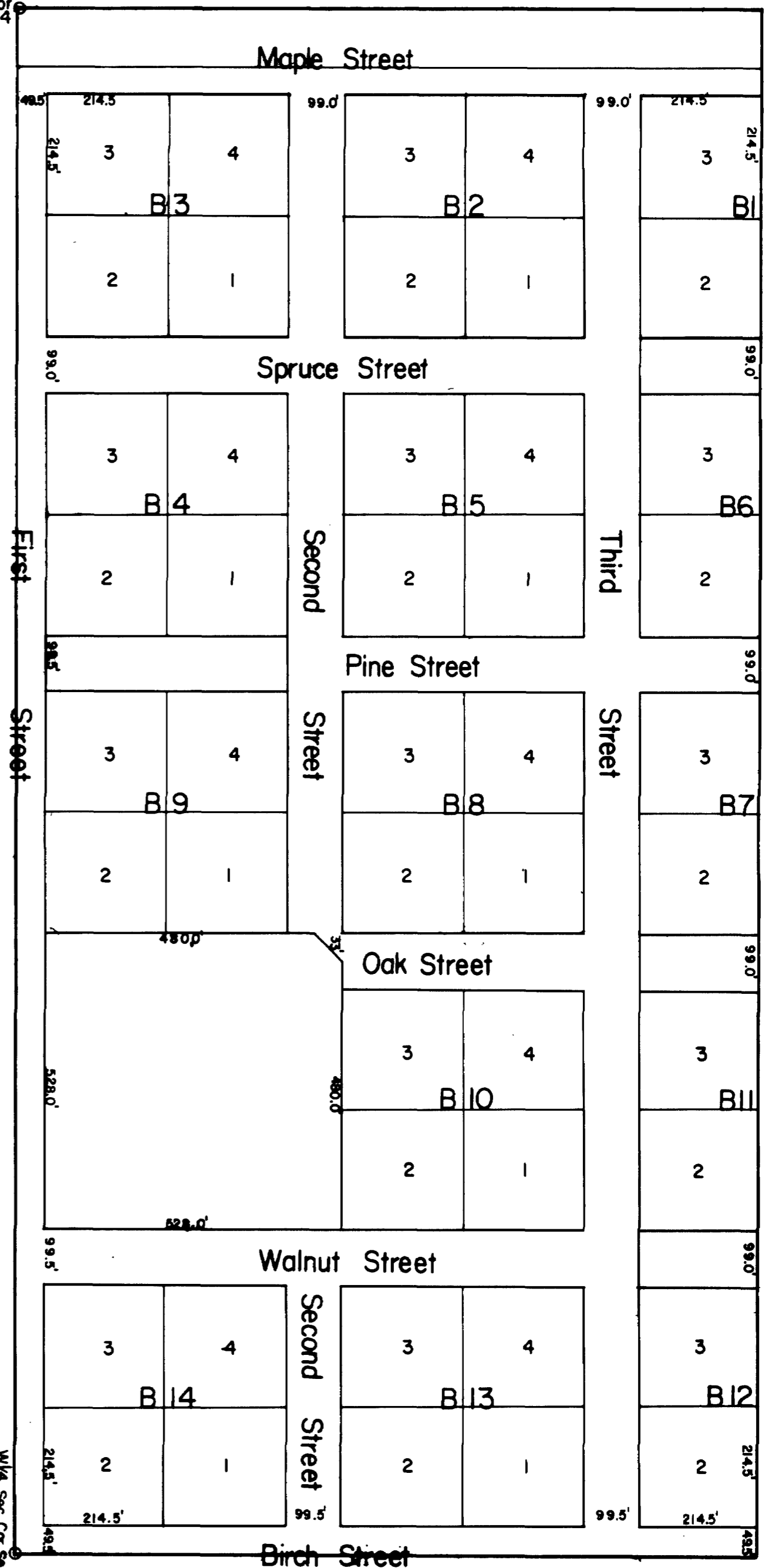
