## QUALIFICATIONS FOR CANDIDATE FILING DECLARATION QUALIFICATIONS

Before the filing officer accepts any declaration of candidacy, the filing officer shall read to the candidate the constitutional and statutory requirements for candidacy, and the candidate shall state whether he/she fulfills the declaration of candidacy (Utah Code Section 20A-9-201,202)

#### COUNTY COMMISSION

Utah Code 17-16-1; 17-53-202

- Registered voter for at least one year before the date of the election.
- Be a registered voter of the county which the member represents.
- At least one year resident of the county immediately before the date of the election.

### COUNTY ASSESSOR

Utah Code 17-16-1; 17-17-2

- A registered voter in the county.
- A current resident of the county in which the person is seeking office and either has been a resident of that county for at least one year.
- Become a state-licensed or state-certified appraiser no later than 36 months after the day on which the individual's term of office begins.

#### COUNTY TREASURER/RECORDER

Utah Code 17-16-1

- A registered voter in the county.
- At least one year resident of the county immediately before the date of the election.
