• Registered voter for at least one year before the date of the election.

• Be a registered voter of the county which the member represents.

• At least one year resident of the county immediately before the date of the election.

COUNTY ASSESSOR

Utah Code 17-16-1; 17-17-2

- A registered voter in the county.
- A current resident of the county in which the person is seeking office and either has been a resident of that county for at least one year.
- Become a state-licensed or state-certified appraiser no later than 36 months after the day on which the individual's term of office begins.

COUNTY TREASURER/RECORDER

Utah Code 17-16-1

- A registered voter in the county.
- At least one year resident of the county immediately before the date of the election.

I shall accept responsibility to take firm action against any subordinate who violates any provision of this pledge or the laws governing elections.

I SHALL defend and uphold the right of every qualified American voter to full and equal participation in the electoral process.
