

2025 DELINQUENT TAX LISTING

December 30, 2025

Pursuant to Utah Code Section 59-2-1332.5, notice is hereby given that, as of the above date, taxes on the following parcels of real property for the 2025 tax year are delinquent. The amount due includes the penalty due as of the same date. If any property that is listed is related to or involved with any bankruptcy, the property is listed for information purposes only and is not an attempt to collect the debt in violation of bankruptcy laws.

Taxes not paid by December 1, 2025, are subject to a penalty of 1% or \$10, whichever is greater. Payments made after that date are applied first to the penalty and then to taxes. If the taxes and penalty are not paid by January 31, 2026, the penalty will increase to 2.5% or \$10, whichever is greater, of the amount of the delinquent taxes and tax notice charges.

Notice is also given that interest will accrue on the taxes and penalty due beginning January 01, 2026, unless paid on or before January 31, 2026.
